### **1. INTRODUCTION**

Feedback plays an essential role in curriculum delivery. It is a regular practice of the IQAC committee to collect feedback on the curriculum from stakeholders, *students, teachers, parents, alumni, and employers,* for the betterment of the institution. To implement this, a **feedback committee** is constituted. The committee collects and analyses the feedback and gives suggestions to the appropriate bodies.

### 2. FEEDBACK COMMITTEE (2019-20)

This year's feedback committee consisted of Dr.Annu Thomas (*Department of Chemistry*), Prof Shalini Thomas(*Department of Economics*), Prof Jaisy Joy(*Department of Chemistry*) and Prof. Alphonsa Kurien(*Department of Sociology*).

This Committee would be responsible for distributing, collecting, filing, analysing and directing the actions taken based on the feedback. This committee acts as an advisory body to the council, allowing them to make changes based on the feedback collected from the previous year. The collected feedback is analysed and suggestions are made to the committee based on the report.

The stakeholders of this feedback are: students, teachers, alumni, parents and employees.


### **3. FEEDBACK METHODOLOGY**

The feedback is collected from the stakeholders through structured questionnaires in the following manner:

- Students the questionnaire is circulated among randomly chosen students at the end of the academic year.
- Parents the questionnaire is distributed to the parents during PTA meetings and Open House meetings conducted by the departments.
- Alumni- the feedback is collected from the alumni during the alumni meets organized in the college.
- Employers- each department was given the responsibility of tracking down their employed alumni and collecting the feedback on them from their employer.

 Teachers - the feedback is taken from the teachers both through a structured questionnaire and during various meetings.

The feedback from the above stakeholders are collected, analysed and then submitted to the College Council and then to IQAC for further implementation. Once the IQAC is convinced of the changes to be made, they put it forward to the Governing Body where the changes are implemented.







#### 5.1.1. SYLLABUS SUITS THE COURSE




62.9% of the students strongly agree that 'the syllabus suits the course', 24.5% agree, 11.3had neutral response and 1% disagree with the statement.

#### 5.1.2. THE SYLLABUS IS APPROPRIATE YET CHALLENGING





### 5.1.3. SYLLABUS IS RELEVANT IN THE CURRENT SCENARIO




62.5% of the students strongly agree that syllabus is relevant in the current scenario, 22.4% agree, 12% have neutral response and 2.9% show disagreement.

### 5.1.4. THE SYLLABUS IS APT FOR JOBS RELATED TO YOUR FIELD







# 5.1.6. THE SYLLABUS REQUIRES GREAT EFFORT BY THE STUDENTS





# 5.1.7. THE SYLLABUS HELPS STUDENTS FACE COMPETITIVE EXAMS





### 5.1.8. THE SYLLABUS INCULCATES ETHICS AND SOCIAL VALUES





### 5.1.10. THE SYLLABUS PROVIDES EXTRA LEARNING




60.8% of the students strongly agree that 'the syllabus provides extra learning', 20.1% agree, 15% had neutral response and 4.0 % disagree with the statement.

### 5.1.12. TEACHERS USE ICT ENABLED TECHNIQUES FOR EFFECTIVE CURRICULUM DELIVERY




37% of the students responded that the teachers use ICT enabled techniques for effective curriculum delivery. 37.6% agree, 11.3% diagree and 14% give neutral response.



#### 5.2.1. SYLLABUS IS SUITABLE TO THE COURSE





### 5.2.2. SYLLABUS IS NEED BASED




43.3% of the teachers strongly agree that the 'Syllabus is Need Based', 35% agree, 8.3% have neutral response and 13.3% disagree with the statement.



### 5.2.4. THE COURSE HAS A GOOD BALANCE BETWEEN THEORY AND PRACTICE





# 5.2.5. THE SYLLABUS HELPS THE STUDENTS FACE COMPETITIVE EXAMS



### 5.2.6. THE COURSE/ SYLLABUS HAS MADE THE TEACHER INTERESTED IN THE SUBJECT AREA







# 5.2.8. THE PRESCRIBED TEXTS ARE RELEVANT, UPDATED AND APPROPRIATE









### 5.3.1. SYLLABUS SUITS THE COURSE





### 5.3.2. THE SYLLABUS IS APPROPRIATE YET CHALLENGING




44.2% of the parents strongly agree that the syllabus is appropriate yet challenging, 40.9% agree, 2.6% have neutral response, 12% disagree







### 5.3.4. THE SYLLABUS IS APT FOR JOBS RELATED TO THIS FIELD




For the statement 'Syllabus is Apt for Jobs Related to This Field'57.7% responded yes, 34.2% responded maybe and 8% responded no.

# 5.3.5. THE SYLLABUS IS COVERED WITHIN THE STIPULATED PERIOD




For the statement 'Syllabus is covered within the Stipulated Period' majority of the parents (66.4%) responded yes,25.5% may be, 8%no.

# 5.3.6. THE SYLLABUS REQUIRES GREAT EFFORT BY THE STUDENTS





# 5.3.7. THE SYLLABUS HELPS STUDENTS FACE COMPETITIVE EXAMS



### 5.3.8. THE SYLLABUS INCULCATES ETHICS AND SOCIAL VALUES






### **5.3.9.** SYLLABUS IS UP TO THE LEVEL OF ADVANCED LEARNERS




### 5.3.11. PROPER EVALUATION IS CONDUCTED FOR EACH COURSE


### **5.3.13. PARENTS ARE SATISFIED WITH THE PASS PERCENTAGE**



#### 5.4.1. THE SYLLABUS HELPED YOU LEARN NEW SKILLS




43.3% of the students strongly agree that the syllabus helped you learn new skills, 29.8% agree, 14.9% had neutral response and 11.9% disagree with the statement.

#### 5.4.2. THE SYLLABUS CREATED INTEREST IN ORDER TO PURSUE HIGHER STUDIES



### 5.4.3. THE SYLLABUS WAS UPDATED ACCORDING TO RECENT TRENDS AND DEVELOPMENTS






### **5.4.4. EMPLOYABILITY IS GIVEN FOCUS**

# 5.4.5. THE SYLLABUS IS SUITABLE FOR JOBS RELATED TO YOUR FIELD





### 5.4.7. THE COURSE CURRICULUM FULFILLED YOUR EXPECTATIONS




49.2% of the alumni strongly agree that 'The course fulfilled your expectations', 37.3% agree, 6% had neutral response and 7.5% disagree with the statement.



### 5.4.9. THE SYLLABUS IMPARTS PRACTICAL KNOWLEDGE





### 5.4.11. THE ASSESSMENT METHODS USED WAS ACCURATE TO TEST THE KNOWLEDGE LEVEL





### 5.5.1. CURRICULUM IS RELEVANT FOR EMPLOYABILITY



# 5.5.2. CURRICULUM IS EFFECTIVE IN DEVELOPING INNOVATIVE THINKING






### 5.5.3. CURRICULUM INCULCATES VALUES AND ETHICS

### **5.5.4.** SYLLABUS IS EFFECTIVE IN DEVELOPING SKILL ORIENTED HUMAN RESOURCES






### **5.5.5.** SYLLABUS IS NEED BASED

### 7. ACTION TAKEN REPORT

From the feedback on the curriculum taken from students, teachers, parents, alumni and employers, it is clear that the stakeholders are happy with the curriculum. However, for the information regarding the teachers using ICT enabled techniques for effective curriculum delivery, students preferred to agree instead of strongly agree. And some students suggested having more smart classrooms in the College for effective curriculum delivery. In response, interactive panels were installed in several departments during 2020-21.
