
### 3. FEEDBACK METHODOLOGY





# 5.1. CURRICULUM IS RELEVANT FOR EMPLOYABILITY





# 5.2. CURRICULUM IS EFFECTIVE IN DEVELOPING INNOVATIVE THINKING





### 5.3. CURRICULUM INCULCATES VALUES AND ETHICS





# 5.4. SYLLABUS IS EFFECTIVE IN DEVELOPING SKILL ORIENTED HUMAN RESOURCES





# 5.5. SYLLABUS IS NEED BASED




