## 3. FEEDBACK METHODOLOGY

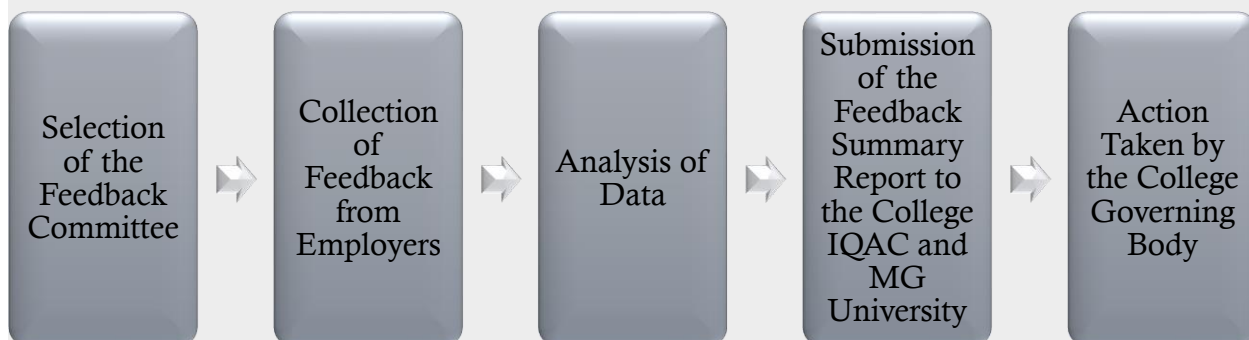

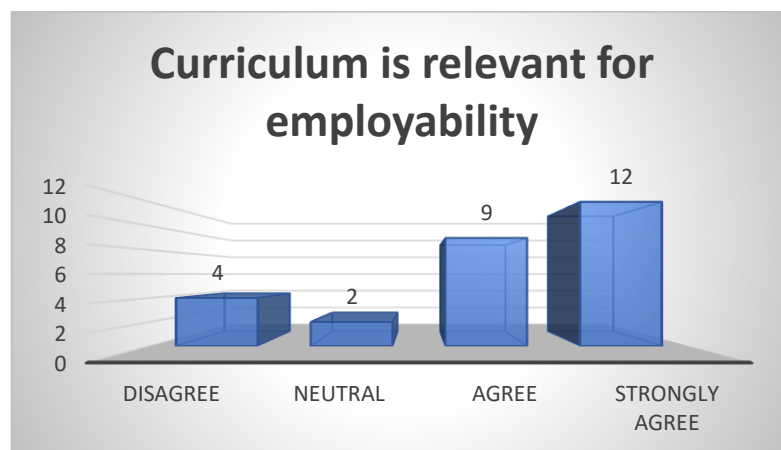

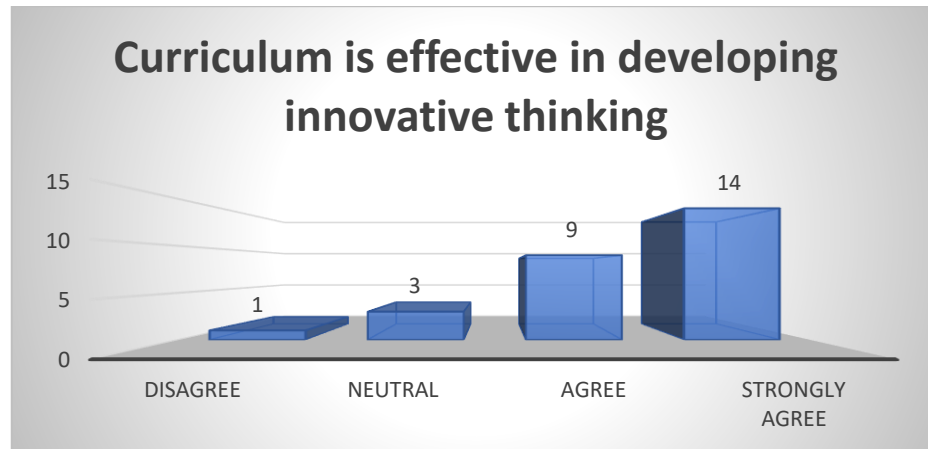

##### 5.1. CURRICULUM IS RELEVANT FOR EMPLOYABILITY



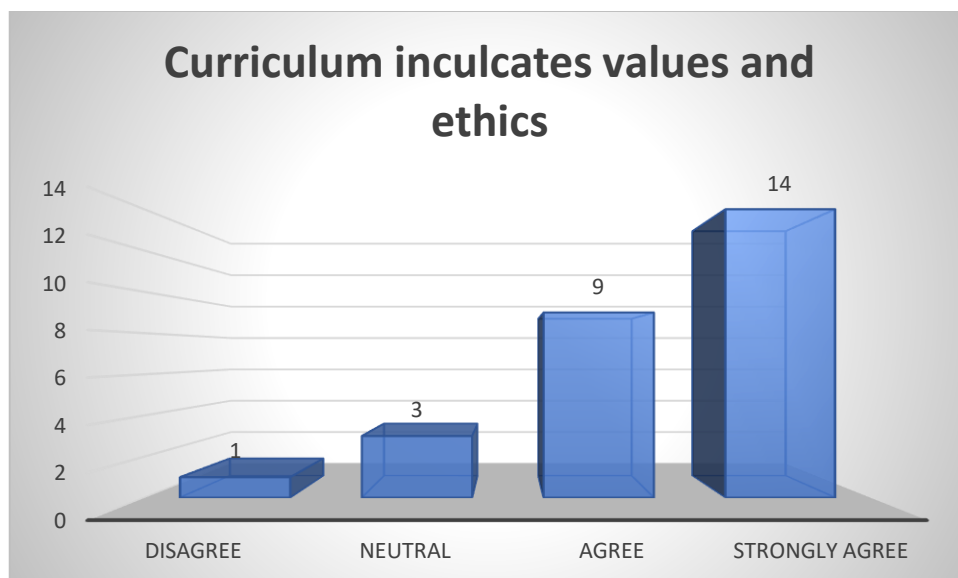

## 5.2. CURRICULUM IS EFFECTIVE IN DEVELOPING INNOVATIVE THINKING



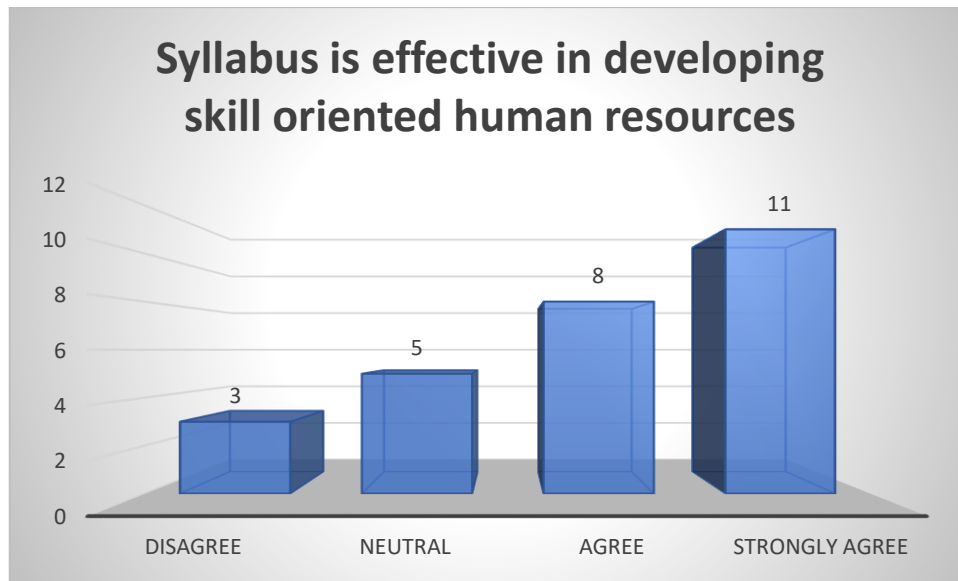

## 5.3. CURRICULUM INCULCATES VALUES AND ETHICS



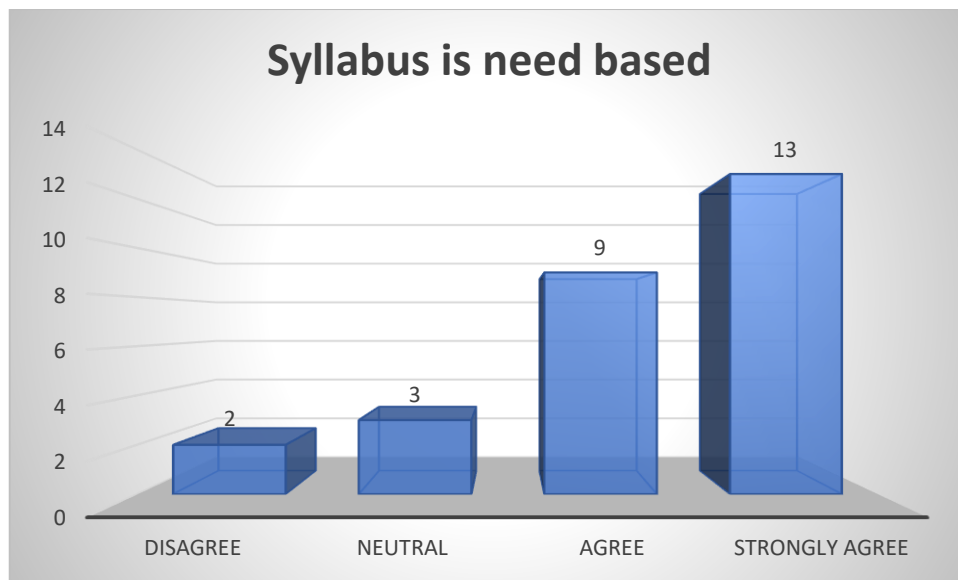

#### 5.4. SYLLABUS IS EFFECTIVE IN DEVELOPING SKILL ORIENTED HUMAN RESOURCES



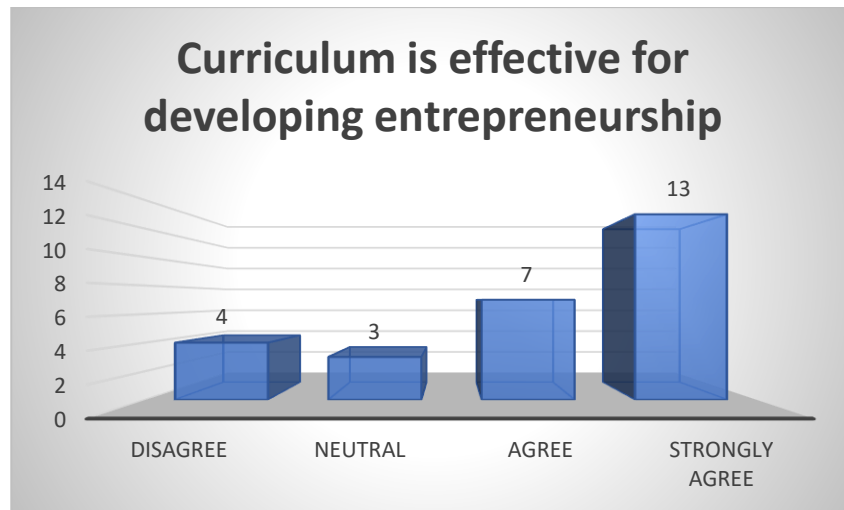

#### 5.5. SYLLABUS IS NEED BASED



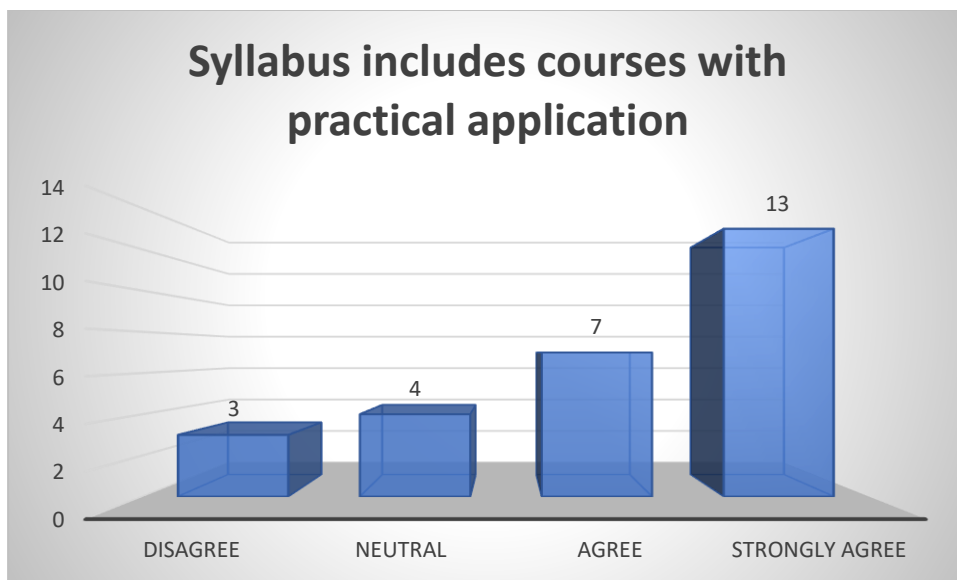
