To work in association with KAPS and other organizations for the cause of Human Rights Protection.




BCM HR-AHT Club

The Universal Declaration of Human Rights (UDHR) was established in response to the atrocities during WW-II, including the Holocaust. The document outlines the human rights that all people are entitled to such as freedom from torture, freedom of expression, and the right to seek asylum. When those rights aren't protected or blatantly disregarded, they are violated.



The human rights violation can be physically violent in nature, or without any physical violence. Civil, political, economic, cultural, and social rights can all be violated through various means. The United Nations relies on civil society actors to spread knowledge and promote new tools in its work to promote human rights and sustainable development, to empower women and young people, to eradicate poverty, and to maintain peace and security, all under the rule of law. Social Workers have a major role in this.
