Theme of Samanwaya2023: 20th Edition: 'CHILD PROTECTION AND SOCIAL RESPONSIBILITY'

Child protection is the safeguarding of children from violence, exploitation, abuse, and neglect. Article 19 of the UN Convention on the Rights of the Child provides for the protection of children in and out of the home. "Child rights are the fundamental freedom and the inherent rights of human beings below the age of 18". These rights to apply irrespective of their gender, caste, race, color or other status. To fully realize children right to protection, it is important to adopt a different attitude towards children and their needs.

Looking at the ever-rising cases of child abuse and neglect, it seems the world requires to spend more time and resources for children. "Children are the asset of every nation". They are fundamental group of human civilization. A Child cannot develop to be responsible and a productive member of our society unless an environment, which is conducive to his /her social and physical health and protection, is assured to him/her children can be considered as the vulnerable group as well. It is very important to protect the children from any kind of problem that may occur to them. Every child has the right to grow up in a safe and inclusive environment.

All children deserve a happy childhood and the opportunity to lead a dignified life safe from violence, exploitation, neglect, deprivation and discrimination. India is a young nation, with a child population of more than 444 million. Protection of this 40% of the young population is not only a matter of their human rights but also an investment towards building a robust nation. The Constitution of India recognize children as equal right holder and grants highest priority for their protection and well-being. India is also signatory to the United Nations Convention on the Rights of the Child (UNCRC) and accordingly has a strong legal framework to protect children which include the Juvenile Justice (Care and Protection of Children) Act 2015; the Protection of Children from Sexual Offences Act 2012; Pre-Conception and Pre-Natal Diagnostic Techniques (PCPNDT) Act 1994; the Commission for Protection of Child Rights Act 2005; the Right of Children to Free and Compulsory Education Act, 2009; Prohibition of Child Marriage Act, 2006; and Child Labour (Prohibition and Regulation) Amendment Act, 2016.

India is among the countries having a significant number of child labourers. "Substantial variation in child labour estimates exists across the South Asian countries. In absolute terms, child labour in 5-17 age group is highest in India (5.8 million), followed by Bangladesh (5 million), Pakistan (3.4 million) and Nepal (2 million)," says ILO report titled 'Child Labour in South Asia. The current policy draws upon the safeguards provided under the Constitutions of India, various child-centric legislation, international treaties as well as other existing policies for the protection and wellbeing of children. It aims at providing a safe and conducive environment for all children through the prevention and response to child abuse, exploitation and neglect. It provides a framework for all institution, and organization (including corporate and media houses), government or private sector to understand their responsibilities in relation to safeguarding/ protecting children and promoting the welfare of children; individually and collectively.

The Covid-19 global pandemic declared by the World Health Organization has become overwhelming and staggering in number of growing cases and deaths worldwide. Aside from getting the virus, children are also still vulnerable to the impacts of this pandemic. They become witness in families struggling with government lockdowns that prevent their parents from earning a living. Some children lost parent because of the disease. School closures, home quarantines, and psychological distress add up to the negative effects on children's emotional, social and physical well-being. And for a child, this intimidating outbreak more than meets the eye. WHO offered several advice for coping with stress for children in a pandemic. During emergencies, it is common and normal for both adults and children to feel sad, nervous, upset, confused, afraid, or irritable, and that talking to someone trusted like family members or friends will improve their mood. Children are able to enjoy life in all its fullness when they feel safe, free and comfortable in their environment – when they enjoy good health, when the people they trust are with them, when the things they need are provided, and when they can perform activities normal activities like going to school and playing with friends, without fear or hesitation.

The world is in a new normal. The changes that happen in the daily life of people seriously affects children too. Children definitely pick up on the stress level in their environment. The right effort to deal with the new normal era is to strengthen child protection based on children's rights, starting from parents, family, community, and government during the pandemic. Associated with the establishment of a policy schedule for children entering school when the new normal era in the

Covid-19 pandemic. Social workers have the responsibility of child protection than any other professionals. All the discussions and sharing of knowledge by various means in the three days conference shall help all participants to get a thorough insight to the child protection issues that the society is likely to experience through the present decade which in turn will help them in their fields towards working for the protection of rights of children and ensuring their proper development. Samanwaya is an excellent platform for sharing on such thoughtsin various areas of children and having presence of eminent professionals.

Child protection is the matter of priority concern for all the nations across the world. All the membercountries of UN are committed to protection of the children in their respective countries by ensuring therights of children based on UNCRC. The initiatives of government machinery through the implementation of various policies andlegislations related to child protection have shown positive results in the protection of children.
